1. What I'll Do

Quan Co. Cards will perform card (Pokémon, Sports, etc.) restoration work on the card(s) submitted by the client.

This can include cleaning, fixing edges, flattening, crease reduction, dent reduction, or other cosmetic improvements.

2. Agreement & Disclaimers

By signing, you confirm that you have read and agreed to all disclaimers, service prices, terms, and conditions.

Acknowledgment of Risk

- Restoration always carries some risk with the use of pressure, tools, solvents, or other techniques to improve visual condition.
- Quan Co. Cards does not guarantee specific outcomes and results may vary depending on the condition of the card.

Non-Alteration Compliance

- All restoration work performed by Quan Co. Cards strictly adheres to a non-alteration policy.
- No ink, paint, fillers, or trimming will be applied to the card.

Release of Liability

- By submitting cards for restoration, the client voluntarily assumes all associated risks and agrees to hold Quan Co. Cards, its owner, and employees free from any and all claims, liabilities, losses, or damages arising from or related to the restoration process.
- This includes, but is not limited to: damage, devaluation, or rejection by a grading authority.

Use of Property for Advertising

- The Client agrees that Quan Co. Cards may photograph, record, and otherwise use images of the Client's property (including before-and-after results) for marketing, social media, and promotional purposes.
- The Client understands that these images may appear on, but are not limited to, social media platforms, websites, and other promotional materials.
- The Client grants Quan Co. Cards permission to use such content without additional compensation.

3. Payment Terms & Refunds

- Payment of the quoted amount is due upon Quan Co. Cards receiving the clients cards and when Quan Co. Cards are set to begin the service.
- Because of the time and materials involved, payments are non-refundable.
- Regardless of client satisfaction with the restoration, if payment is not made within seven (7) working days—without written extension granted by Quan Co. Cards via email, Discord, or Instagram Direct Messaging—the cards in question will be deemed abandoned property and become the sole and legal property of Quan Co. Cards without further notice or compensation.

Agreement on Price:
